
Takeover offer by Wildweb Enterprises Pty Ltd for Kresta Holdings Limited - fourth supplementary bidder's statement

Fourth Supplementary Bidder's Statement

*This is the fourth supplementary bidder's statement (**Fourth Supplementary Bidder's Statement**) under section 643 of the Corporations Act 2001 (Cth) issued by Wildweb Enterprises Pty Ltd ACN 147 842 546 (**Wildweb**), in connection with Wildweb's conditional off-market takeover offer to acquire all of the fully paid ordinary shares in Kresta Holdings Limited ACN 008 675 803 (**Kresta**) contained in Wildweb's bidder's statement dated 3 February 2011 (**Bidder's Statement**), as supplemented by a first supplementary bidder's statement dated 15 February 2011 (**First Supplementary Bidder's Statement**), a second supplementary bidder's statement dated 4 March 2011 (**Second Supplementary Bidder's Statement**) and a third supplementary bidder's statement dated 14 March 2011 (**Third Supplementary Bidder's Statement**). This Fourth Supplementary Bidder's Statement supplements, and should be read together with the Bidder's Statement, the First Supplementary Bidder's Statement, the Second Supplementary Bidder's Statement and the Third Supplementary Bidder's Statement. Unless the context otherwise requires, terms defined in the Bidder's Statement have the same meaning in this Fourth Supplementary Bidder's Statement.*

Wildweb Enterprises Limited (**Wildweb**) advises that its takeover offer for Kresta Holdings Limited (**Kresta**) will effectively close tomorrow (Thursday 17 March 2011) unless it has received minimum valid acceptances which take its interest to not less than 40% of Kresta.

As previously announced, the passing of the resolutions at the Kresta EGM held on 14 March has triggered a bid condition. Wildweb has determined it will not waive or remove the EGM condition unless it has received minimum valid acceptances which take its interest to not less than 40% of Kresta.

The offer period will also not be extended.

If, at the end of the offer period, the conditions have not been fulfilled and the offer has not been freed from the conditions, all contracts resulting from the acceptances of the offer will be automatically void.

A copy of this Fourth Supplementary Bidder's Statement has been lodged with ASIC on 16 March 2011. Neither ASIC nor any of its officers take any responsibility for its contents.

This Fourth Supplementary Bidder's Statement has been approved by a resolution passed by the sole director of Wildweb.
